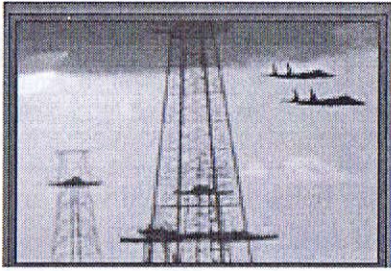


Why are US Troops Dying in the Middle East?

Iraq Oil Ministry an untouched building in ravaged Baghdad, April 16 2003

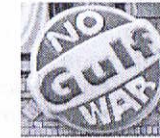

Shades of Daniel Plainview, the monstrous petroleum tycoon in the movie, **"There Will Be Blood."** half-mad, he exclaims, *"There's a whole ocean of oil under our feet!"* then adds, *"No one can get at it except for me!"* No wonder American troops

While many regions of the world offer great oil opportunities, the Middle East, with two-thirds of the world's oil and the lowest cost, is still where the prize ultimately lies."*

BOMBSHELL: US Promised 'Carpet of Gold' to Taliban in Exchange for Oil.

Under the influence of U.S. oil companies, the government of George W. Bush initially blocked U.S. secret service investigations on terrorism, while it bargained with the Taliban the delivery of Osama bin Laden in exchange for political recognition and economic aid, two French intelligence analysts claim.

In the book "Bin Laden, la verité interdite" ("Bin Laden, the forbidden truth"), that appeared in Paris on Wednesday, the authors, Jean-

Charles Brisard and Guillaume Dasquie, reveal that the Federal Bureau of Investigation's deputy director John O'Neill resigned in July in protest over the obstruction.

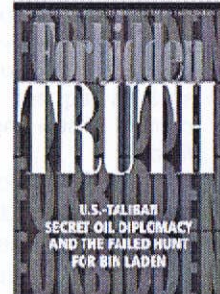
Brisard claim O'Neill told them that *"the main obstacles to investigate Islamic terrorism were U.S. oil corporate interests and the role played by Saudi Arabia in it"*.

The two claim the U.S. government's main objective in Afghanistan was to consolidate the position of the Taliban regime to obtain access to the oil and gas reserves in Central Asia.

They affirm that until August, the U.S. government saw the Taliban regime "as a source of stability in Central Asia that would enable the construction of an oil pipeline across Central Asia", from the rich oilfields in Turkmenistan, Uzbekistan, and Kazakhstan, through Afghanistan and Pakistan, to the Indian Ocean.

Until now, says the book, "the oil and gas reserves of Central Asia have been controlled by Russia. The Bush government wanted to change all that". But, confronted with Taliban's refusal to accept U.S. conditions, "this rationale of energy security changed into a military one", the authors claim.

"At one moment during the negotiations, the U.S. representatives told the Taliban, 'either you accept our offer of a carpet of gold, or we BURY you under a carpet of bombs'," Brisard said in an interview in Paris.



There's a story, perhaps apocryphal, that Pentagon planners wanted to name the invasion of Iraq, "Operation Iraqi Liberation." Only when someone realized that the acronym - O.I.L. -was it changed.

Fast forward to Cheney's first heady days in the White House. The oil industry and other energy conglomerates were handed backdoor keys to the White House, and their CEO's and lobbyists were trooping in and out for meetings with their old pal, now Vice President Cheney. The meetings were

secret, conducted under tight security, but as we reported five years ago, among the documents that turned up from some of those meetings were maps of oil fields in Iraq - and a list of companies who wanted access to them. The conservative group Judicial Watch and the Sierra Club filed suit to try to find out who attended the meetings and what was discussed, but the White House fought all the way to the Supreme Court to keep the press and public from learning the whole truth.

Former Treasury Secretary Paul O'Neill told author Ron Suskind that Dick Cheney also supported an invasion of Iraq before Sept. 11, and the *New Yorker's* Jane Mayer reported on a top-secret National Security Council document dating back seven months before the (govt-sponsored) 9-11 terror attacks that gave some insight into the vice president's thinking:

It directed the N.S.C. staff to cooperate fully with [Cheney's secretive] Energy Task Force as it considered the "melding" of two seemingly unrelated areas of policy: "the review of operational policies towards rogue states," such as Iraq, and "actions regarding the capture of new and existing oil and gas fields."

In her new book, "**The Bush Agenda**," Antonia Juhasz detailed how, six months before the invasion, the administration brought in a group of oil executives to advise them on Iraqi oil policy (*this occurred as Pres. Bush told the American people that he had no intention of going to war*).

Think about it. These secret meetings took place six months before 9/11, two years before Bush and Cheney invaded Iraq. What we know is that this is the oil industry that's enjoying swollen profits these days. It would be laughable if it weren't so painful to remember that their erstwhile cheerleader for invading Iraq - the press mogul Rupert Murdoch - once said that a successful war there would bring us \$20-a-barrel oil. The last time we looked, it was more than \$140 a barrel. Where are you, Rupert, when the

Record Profits from Big Five Oil Companies Feed on High Gas Prices

High gas prices may have cinched American consumers' wallets in 2007, but they loaded the coffers of the big five oil companies: BP, Chevron, Conoco Phillips, ExxonMobil, and Shell. ExxonMobil, after record high profits in 2005 and 2006, smashed the record for highest profits ever made by a public U.S. company—previously held by Exxon—by posting a net profit of \$40.6 billion in 2007. VP Cheney had Iraqi oil field maps on his desk prior to the Iraq invasion!

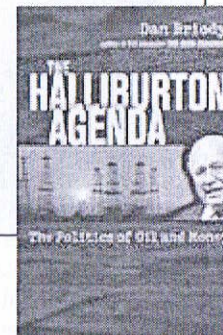
America (Pres. Bush) was itself to blame for the events of September 11 because the US administration was using "kid gloves" in tracking down Osama bin Laden and "other fanatics linked to Saudi Arabia", a special BBC investigation has alleged in a damning indictment of the two presidents Bush...

The report, which the BBC claimed was based on a secret FBI document, numbered 199J WF213589 and emanating out of the FBI's Washington field office, alleged that the cynicism of the American establishment and "connections between the CIA and Saudi Arabia and the Bush men and bin Ladens" may have been the *real cause* of the deaths of thousands in the World Trade Centre attacks.

The investigation, which featured in the BBC's leading current affairs programme, *Newsnight*, said the FBI was told (by Bush) to **"back off"** investigating one of Osama bin Laden's brothers, Abdullah, who was linked to "the Saudi-funded World Association of Muslim Youth (WAMY), a suspected terrorist organisation," ...

Newsnight said there was a long history of "shadowy" American connections with Saudi Arabia, not least the two presidents Bush's "business dealings" with the bin Ladens and another more insidious link revealed by the former head of the American visa section in Jeddah.

The official said he had been concerned about visas issued to large numbers of "unqualified" men "with no family links or any links with America or Saudi Arabia", only to find out later that it "was not visa fraud" but part of a scheme in which young men "recruited by Osama bin Laden" were being sent for "terrorist training by the CIA" after which they were sent on to Afghanistan.



In a reiteration of a now well-known claim by one of George W Bush's former business partners, the BBC said he made his first million 20 years ago on the back of a company financed by Osama's elder brother, Salem. But it added the more disturbing assertion that both presidents Bush had lucrative stakes along with the bin Ladens in Carlyle Corporation, a small private company which has gone on to become one of America's biggest US defense contractors.

After being threatened with arrest, FBI special agent Robert Wright, along with Larry Klayman, President of Judicial Watch, got up on national TV (C-SPAN) and said, *"We can't tell you what we know. Here's a letter threatening to arrest us,"* then added, *"all we can [tell you] is the Bushs vacation with the Bin Ladens."*
