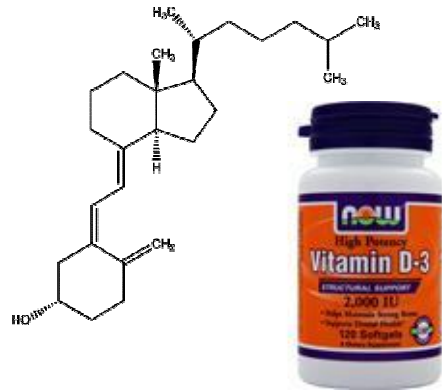

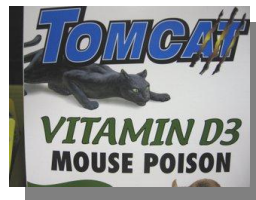
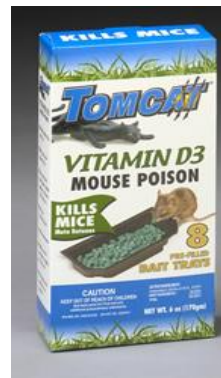


The FDA has allowed the marketing and sale of cholecalciferol based Rat Baits to the American people as a “vitamin”. As crazy as it sounds – the American public must be told: **YOUR VITAMIN “D3” SUPPLEMENT IS RAT POISON!**



### QUINTOX MOUSE & RAT BAIT

Active ingredient in Quintox is Cholecalciferol or **Vitamin D3**. When ingested, it mobilizes calcium from the rodent's bones into its bloodstream, producing hypercalcemia and heart failure. Quintox acts faster than anticoagulants, causing death in 2 to 4 days, with feeding stopping immediately once the rodent eats a lethal dose. **Testing has shown this bait to be highly effective**, even against anticoagulant resistant rodent populations. Very little risk of secondary poisoning (e.g., if your cat or dog catches a poisoned mouse). However, pets and children should be kept from being able to access and/or consume the bait (please note that rodents may move the bait around, so exercise vigilance and caution if pets and/or children are a factor).



### TOMCAT Brand... VITAMIN D3 MOUSE POISON

Cholecalciferol is Vitamin D3. Not only is it found in rodenticides like Rampage, Quintox, Tomcat and Rat-B-Gone, it is also found in multivitamins and some calcium supplements like Viactiv. While it is possible for a pet to be overdosed on Vitamin D3 by eating vitamin or mineral supplements, **the risk is MUCH greater from ingesting rodenticides containing cholecalciferol.** Toxicity is especially dangerous because the half-life of cholecalciferol is very long, so the dog may need treatment for several weeks. It's an awful, painful, and often fatal type of poisoning. (As revealed during the pet deaths and mass poisoning of cats and dogs in 2007 from over-dosage of Vitamin D3 in the pet foods!)



## PET TREATMENT Vitamin D3 Poisoning

*“Rampage Rat Bait is a popular cereal bait poison that contains Vitamin D3 (cholecalciferol). Toxic levels of Vitamin D3 cause a sudden rise in blood calcium levels (hypercalcemia), leading to vomiting and diarrhea, seizures and heart and kidney failure. Treatment is directed at lowering the serum calcium and requires veterinary management.”*

### Massive Pet Food Recall After Animal Deaths

60 millions cans and pouches of pet food were recalled this weekend after being linked to 10 animal deaths by **kidney failure**. Menu Foods announced the recall on “cuts and gravy” style pet food sold under numerous brands, including store brands for Wal-Mart, Kroger, and Safeway, as well as name-brands like Nestle Purina Pet-Care and Science Diet. Recent dog food fiascos demonstrate how important it is to buy pet food from a reputable company. .. This month, Royal Canin recalled dog and cat food because it contains **enough Vitamin D3 to be toxic**. In minute amounts Vitamin D3 is beneficial, but **in large amounts, it is toxic**. In fact, Vitamin D3 is the poison used to kill rats in several popular products: Rampage Rat and Mouse Bait, Ortho Rat-B-Gone, and Quintox Rat and Mouse Bait. Most baits contain 0.075% cholecalciferol and at this concentration 1 tablespoon of bait kills a 40-lb dog.

Although the concentration of Vitamin D3 in Royal Canin is not great enough to kill mice or dogs, it's important to realize how toxic Vitamin D3 is. Symptoms appear within 12-36 hours of eating food or bait and intensify over time. Pets lose their appetite (anorexia), have vomiting, diarrhea, intestinal bleeding, fever, and an irregular heart rate.

Because Vitamin D3 increases calcium in the body, the **kidneys and heart become calcified**. Symptoms lead to chronic illness and death. To prevent problems like this in your pets, don't expose them to rat poisons, and avoid dog foods from companies without stellar records.

## Death Toll From Pet Food Over 3,900; Hearing Due



As the death toll of pets from contaminated pet food rises, the U.S. Senate will conduct an open session oversight hearing Thursday afternoon centering on the continuing investigation of one of the largest product recalls in U.S. history and the regulatory mechanisms that govern the pet food industry.

As of early Wednesday, PetConnection was reporting that 3,907 pets have been reported as deceased as the result of the **tainted pet food which results in KIDNEY FAILURE**. Of these, 2,026 are cats and 1,881 are dogs. Total reports of all owner-suspected cases of food-related illness are at 12,174, according to PetConnection which cautions that the numbers have not been verified. But if even a fraction of them can be confirmed, the figures show deaths far exceeding the FDA's count of 16 pets, seven of whom died in a feeding trial conducted by Menu Foods of Streetsville, Ontario.

**Vitamin D3:** Small quantities of cholecalciferol (Vitamin D3), which is used in its pure form as a rat poison, leaves few forensic traces, and may lead – once symptoms appear—to an untreatable calcification of the arteries and heart muscle, were produced under the auspices of Project Coast (conducted in violation of the commitments of the South African government to the Biological and Toxins Weapons Convention). (Only large doses of cholecalciferol are likely to cause death in humans, but perhaps the South Africans developed a scheme for using it to induce fatal poisoning.) This may have been done originally at Delta G Scientific, the principal South African CW research and production facility, but whatever its source Vitamin D3 was later tested at Roodeplaat Research Laboratories, the main BW research, testing, and production facility. Some of it may have ... ended up being consumed by targeted enemies.

At RRL, where Dr. Mike Odendaal and Dr. James Davies were also involved in testing the effects of various poisonous substances by mixing them into food and beverages, Dr. Stiaan Wandrag carried out research on Vitamin D3. After producing these poisons and contaminated items, these researchers handed them over to Dr. André Immelman, RRL's R&D director... On the purported instructions of Project Officer Wouter Basson, Immelman later secretly transferred Vitamin D3 and other highly toxic substances to military and police personnel through various channels. Some of these dangerous materials were provided to Dr. R. F. Botha (alternately known as "Kooos", "Mr. R", and "Frans Brink") and then to Vernon Lange (otherwise known as "Mr. T" and "Theo"), both of whom were operatives of the Civil Cooperation Bureau (CCB), a covert assassination unit operating under the aegis of the Special Forces (SF). ... Another reported recipient of RRL's poisons was Johnny Koortzen, an ex-South African Defense Force (SADF) psychologist who in 1988 assumed control over Systems Research and Development, a company that bioengineer Jan Lourens had set up in part to manufacture special "applicators," i.e., arcane assassination devices. Some of these toxic materials and devices were subsequently used to assassinate designated "enemies of the state"—guerrillas in neighboring countries, troublesome prisoners, untrustworthy members of the security forces, or activists in the African National Congress (ANC) and other South African opposition groups.

Vitamin D3-cholecalciferol is one of the fat soluble vitamins and is used as a rodenticide. It is a white, odorless crystalline salt. Daily ingestions in excess of 2000IU in children or 1,88mg in adults may produce toxic symptoms within weeks or months. Most of the acute toxic effects of Vitamin D3 overdose are due to a rise in blood calcium (**hypercalcemia**). In acute overdose, patients may present with

nausea, vomiting, diarrhea, headache, itching, weakness, peripheral nerve damage, depression, confusion, heart rhythm disturbances and myocardial infarction.

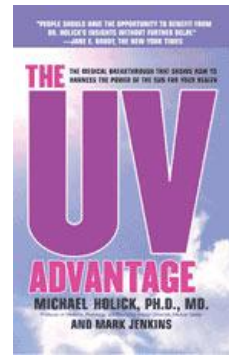
**THE REAL THING!**

rather than as a "steroid hormone". Vitamin D is photochemically produced in the skin's fatty layers by exposure to UV-B rays. Further UV exposure simply causes the photoisomerization of previtamin D to lumisterol and tachysterol, which are both biologically inert. The newly produced vitamin D that is formed in the skin is removed by binding to the plasma transport protein, the vitamin D-binding protein (DBP), present in the capillary bed of the dermis. DBP-vitamin D then enters the general circulatory system where it ultimately can be metabolized in the liver to 25 hydroxyvitamin D [25 (OH)D, or calcidiol] and then in the kidney to 1a,25-dihydroxy-vitamin D [1a,25(OH)2D3, or calcitriol]."

Vitamin D supplementation cannot be accomplished thru artificial synthetic channels. The patented manufactured un-natural "D3" supplementation causes blood acidosis. 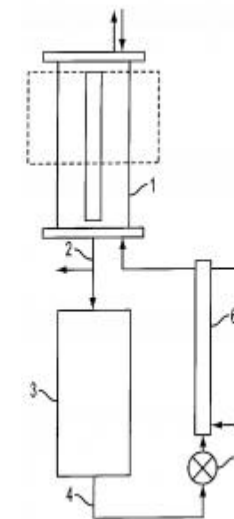
Miscellaneous Rodenticides –

**Cholecalciferol** -Cholecalciferol is the activated form of Vitamin D (Vitamin D3). Its **TOXIC effect** is probably a combination of actions on liver, kidney, and possibly the myocardium, the last two toxicities being the result of hypercalcemia. Early symptoms and signs of Vitamin D3 induced hypercalcemia in humans are fatigue, weakness, headache and nausea. Polyuria, polydipsia, proteinuria and azotemia result from acute renal tubular injury by hypercalcemia. This is ... the cause of death.

**Confirmation of Poisoning** - Cholecalciferol intoxication is indicated by an elevated concentration of calcium in the (blood) serum..." (hypercalcemia)!  
**Treatment: Cholecalciferol** (Vit. D3) Cholecalciferol at high dosage may cause severe poisoning and death..."

A photochemical process for the production of previtamin D.sub.3 or a derivative thereof from 7-dehydrocholesterol is disclosed. The process includes irradiating the 7-dehydrocholesterol in a reactor with a UV radiation source, wherein the UV source includes an excimer or exciplex emitter which emits quasi-monochromatically according to the corona discharge mechanism in the UV range, and recovering previtamin D.sub.3 or a derivative thereof. Previtamin D.sub.3 compositions and derivatives made from this process are also provided.
