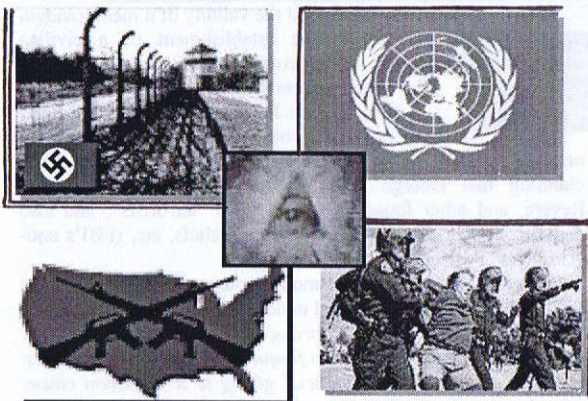

#### Constitution: Fact or Fiction

Through the insidious, yet steady encroachment of "emergency powers," the government has now achieved the ability to rule over the people by statute or decree, without the vote or consent of the citizenry. Through a maze of political maneuvers, the emergency powers granted to President Franklin D. Roosevelt in 1933 to deal with the federal bankruptcy and consequent "great" depression have become part of the US Code as permanent everyday powers. America has continued under an "unconstitutional dictatorship" of war and emergency powers to this day, more than 60 years later.

When Franklin D. Roosevelt was inaugurated on March 4, 1933, he called for an emergency session of Congress on March 9th, where the Emergency Banking Relief Act (also known as the War Powers Act, which seized all the country's constitutional gold and silver coinage) was passed, which gave FDR the power to issue any order, and do anything he felt was necessary to run the country, without restriction, by authority of the Trading with the Enemy Act of October 6, 1917 (which placed all German citizens under the authority of the President, because they were enemies of the U.S.).

In 1917, Chapter 106, Section 2, subdivision (c), of the Trading with the Enemy Act, defined the **Enemy** as someone "other than citizens of the United States..." **BUT** then in 1933, according to Chapter 106, Section 5, subdivision (b), the Act designated as the **Enemy** "any person WITHIN the United States"

America remains under the authority of this **EMERGENCY WAR GOVERNMENT!** According to this book, *Constitution: Fact or Fiction*, the Constitution was NULLIFIED on March 9, 1933, when President Franklin Roosevelt declared the financial "national emergency" manufactured by the private foreign-owned Federal Reserve central bank (treasonous Federal Reserve Act of 1913).

As recorded in the *Congressional Record* in 1933, Congressional Representative James Buck then said...

"...the doctrine of emergency is the worst. It means that when Congress declares an emergency, there is **NO Constitution. This means it's dead.**"

Senate Report 93-549 (Senate Resolution 9, 93rd Congress, 1st Session) in 1973 said that since 1933...

"the United States has been in a state of declared national emergency ... A majority of the people of the United States have lived all their lives under emergency rule. For 40 years freedoms and governmental procedures guaranteed by the Constitution have, in varying degrees, been abridged by laws brought into force by states of national emergency..."

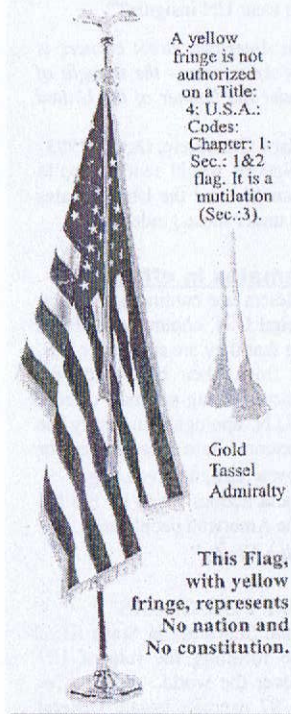

Pursuant to the "Law of the Flag," a military flag does result in jurisdictional implications when flown.

(Ruhstrat v. People, 57 N.E. 41, 45, 185 Ill. 133, 49 LRA 181,76 Am). Under the powers designated by these statutes, the President may: seize property, organize and control the means of production, seize commodities, assign military forces abroad, institute martial law, seize and control all transportation and communications, regulate the operation of private enterprise, restrict travel, and, in a plethora of particular ways, control the lives of all American citizens. (United States Senate Report 93-549, 19 Nov. 1973).

With the abrogation of the US Constitution by the Emergency War Powers Act still in place, the United Nations Charter (treaty) became the "supreme law" of the land since ratification by treasonous politicians

"The Charter of the United Nations has become the 'supreme law of the land' and the judges in every State shall be bound thereby, and any thing in the Constitution or laws of any State to the contrary notwithstanding... The position of this country in the family of nations demands that every State in the Union accept and act upon the Charter (of the United Nations) according to its plain language and its unmistakable purpose and intent."

REVIEW OF THE UNITED NATIONS CHARTER, US Senate Doc #87, p 289, 7 January 1954.

The Senate and President obligated the United States (a bankrupt corporation), as a member of the United Nations "To accept and carry out the decisions of the (U.N.) Security Council in accordance with the present charter." - U.N. Charter, Article 25

#### US Public Law 87-297

An Act to establish a United States Arms Control and Disarmament Agency, 75 Stat. 531, signed by President John F. Kennedy on September 26, 1961. USC Title 22, Sec.2551 requires the permanent transfer of US armed forces to military commanders of the communist-dominated UN Security Council. The goal of this unconstitutional piece of government "law" is the complete disarmament of US citizens and "looking toward ultimate world disarmament"...

Definitions, Sec.3. As used in this act -

(a) The terms "arms control" and "disarmament" mean: the identification, verification, inspection, limitation, control, reduction, or ELIMINATION of armed forces and armaments of ALL KINDS under international agreement ..."

Various federal gun confiscation drills are taking place all over the "New Amerika." On Saturday, July 17, 2004 an unknown shooter wounded an Oshkosh, Wisconsin, police officer, then faded into the night. Was the shot fired by a partying teenager? Was it an accidental discharge from another officer's gun? Was it a mistake or an intentional assault? No one knows. What happened next is unclear; everyone gives a different version of the events.

According to the most credible reports, the Oshkosh PD evacuated a several block area. Without warrants in the immediate aftermath of the shooting, SWAT teams and police dogs descended on the neighborhood. Officers "got" consent to search homes. Once inside, police officers confiscated firearms -- without warrants, without consent, without probable cause. **US FORCES UNDER UN COMMAND**

Rockefeller minion former President Bill Clinton signed Presidential Decision Directive #25 on May 3, 1994. This E.O. forced all U.S. soldiers to wear UN uniforms and report to foreign UN commanders. This policy resulted in the court-martial and discharge of Michael New, who refused to follow this illegal and unconstitutional order. The outrage that greeted this case prompted Bush to make his promise that he would "never" place U.S. troops under U.N. command.

Now there remains no constitutional military forces in the USA by which to defend the country against the UN gun confiscation agenda. A patriotic American soldier was court martialed and dishonorably discharged for refusing to wear a United Nations uniform and to serve under a foreign commander (US v. Michael New, SPC US Army, Jan.1996). When U.S. Army Specialist Michael New took the oath to defend the United States from its enemies and to uphold the U.S. Constitution, he meant exactly that. He had no idea that he would be asked to ignore that oath in order to serve the United Nations, wearing UN insignia and following orders from a foreign UN commander. But that is exactly what happened in August. Michael New was serving in Germany when he was told that his unit was to be sent to Macedonia for UN "peacekeeping" operations. In Macedonia, he would be expected to take directions from a foreign officer and wear UN garb. His mission heading stated that his unit would act to "make the UN presence known." His response, as reported in the cover story of *The New American*, Oct. 2, 1995, p. 5:

"I have a problem with that, because I am **not** UN. I explained this to my lieutenant, and told him, 'Sir, I don't think I should have to wear a UN arm band or a UN beret. I'm enlisted in the U.S. Army; I am not a U.N. soldier. I have taken NO vow to the UN; I have

taken an oath to defend the Constitution of the United States of America from enemies foreign and domestic. I regard the UN as a separate power.... Where does my oath say that I have to wear UN insignia?"

*"The very thought of UN troops on American street corners is undoubtedly offensive to millions of Americans - the thought of soldiers from around the world, under the banner of the United Nations, taking over our streets."*

**ONE WORLD ARMY - READY FOR CRISIS**

The US armed forces of the United States are in Stage III of the Disarmament Program and are fulfilling the role of UN peacekeepers all over the world. As the Co-operative Nugget '97 exercise began, General John Sheehan, USMC, Supreme Allied Commander NATO Atlantic spouted Orwellian doublespeak in his opening remarks. He said, *"To the soldiers assembled here today, I congratulate you because you truly are the next generation of peacemakers."*

"Peacemaker" interpreted means: "one who enforces the edicts of the UN on uncooperative civilians"... War in the name of peace.

This was best illustrated by the recent Cooperative Nugget '97 exercises, conducted from June 11 thru July 4, 1997 at the U.S. Army's Joint Readiness Training Center at Fort Polk, Louisiana. 2,500 U.S. troops as well as 1,100 troops from UN-NATO and "Partnership for Peace" countries participated. Exercises emphasized "peace-keeping" skills such as how to deal with hostile civilians, protesters, conflict between ethnic groups, snipers, how to evacuate the wounded, etc On April 22, 1994 soldiers from the U.S., France, the Netherlands trained in Operation Agile Provider '94, which was conducted in several southern U.S. states and trained in "forcible entry". In 1995, military personnel of the "former" communist countries of Bulgaria, the Czech Republic, Estonia, Hungary, Kyrgyzstan, Latvia, Lithuania, Poland, Romania, Slovakia, Ukraine and Uzbekistan will join with NATO troops from Britain, Canada and the United States to form a peacekeeping force 4,200 strong.

On June 13 and 14, 1995 helicopters from the U.S. Army Special Operations Command at Fort Bragg, N.C., flew to two Chicago suburbs at low level at night without notifying the pub-

lic beforehand. There was gunfire, explosions, windows in homes were rattled, and an abandoned seminary was invaded to "give the pilots a chance to train in an urban environment," according to the Defense Department (Source: *Road to Socialism and the New World Order* by Dennis Cuddy, Ph.D.) There are many credible reports of military forces suddenly "invading" a peaceful, American community, terrorizing its inhabitants and causing an uproar, all in the name of a "training exercise."

The next piece of the "terror" puzzle is now in place. President George W. Bush signed legislation turning the "Homeland Security Act of 2002" into law on November 26, 2002 (Public Law 107-296) which intended to re-classify Americans as being "domestic terrorists" if they object to the surrender or seizure of their privately owned firearms or believe that there is a right for the people collectively to possess firearms under the Second Amendment.

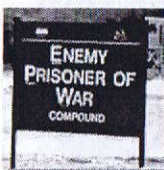

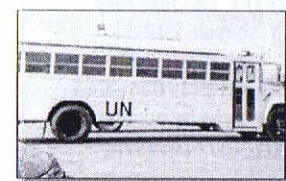
